The above bid results were immediately posted on the District's website and given to H2M Architects & Engineers for review and recommendation to the Board.

Mr. Logan informed the Commissioners that after the Wheatley Tank was drained for the anniversary inspection, it was determined that sediment at the bottom of the tank would need to be removed before putting the tank back into service. Mr. Logan attempted to receive three quotes for the cleaning of the tank, however due to the tight timeframe and limited number contractors able to perform the work, he was only able to obtain one quote. Nuco Painting Corp. was able to complete the work on Saturday April 8<sup>th</sup>, 2022 for the not to exceed amount of \$18,000.00 (negotiated down from \$22,000.00). Mr. Logan received verbal authorization from the Commissioners on April 7<sup>th</sup>, 2022. After discussion, and upon motion duly made and seconded, it was

RESOLVED, that the Commissioners approve the proposal for the cleaning of the interior of the Wheatley Tank from Nuco Painting Corp. in the amount of \$18,000.00 to be charged to Capital Project Account No. H-8397-002-2303 Wheatley Tank Rehabilitation.


