The above bid results were immediately posted on the District's website and given to D&B Engineering Architects for review and recommendation to the Board.

Mr. Logan requested authorization to utilize the District's Requirements Contract No. G1-23, Requirements Contract for Permanent Road Restoration of Pavements with DeRosa Paving to repair the road on White Oak Tree Road, Oyster Bay Cove, for the not to exceed fee of \$26,033.70. The road was damaged by a 10" water main break back in December of 2022. The District's Repair Crew made the repair to the main but left temporary cold patch to make the roadway safe. The damage that was caused by the break was quite extensive to the road, and requires repaying 70' of roadway curb to curb. After discussion, and upon motion duly made and seconded it was

Miss Cannon then informed the Commissioners that the District was awarded a \$50,000.00 Grant from the Coronavirus State and Local Fiscal Recovery Funds (CSLFRF) as provided for by the American Rescue Plan Act of 2021 from Nassau County. To complete the award and receive funding, the District will need to execute the Award Notification Letter, complete the Direct Payment Claim Voucher and Monitoring Budget Report within ten (10) business days. After discussion, the Commissioner authorized Commissioner Abbate to execute the Award Notification Letter on behalf of the District.

Miss Cannon then indicated that she received an Affidavit of Positing from the Town of Oyster Bay with regards to the District's adoption of a Standard Work Day Resolution on January 4, 2023. Miss Cannon indicated posting this resolution on the Town Clerk's sign board for thirty (30) days was required under New York State Comptroller Regulation No. 315.4. Miss Cannon indicated she certified and submit the Standard Work Day Resolution to the Comptroller's Office as required.

Miss Cannon then informed the Commissioners that she had received a FOIL request from Caren Lazarus requesting maintenance records leading up to April 13, 2022 for the fire hydrants located in Hidden Ridge in Syosset. Miss Cannon informed the Commissioners she will send Ms. Lazarus a letter acknowledging receipt of her FOIL request within five (5) days of receipt of her request as required under Section 89 (3) of the Freedom of Information Law.

Miss Cannon informed the Commissioners that she received the following four (4) requests to waive penalties:

- 1. Account No. 55600440-0 in the amount of \$80.94
- 2. Account No. 60153980-0 in the amount of \$109.24

- 3. Account No. 75458380-0 in the amount of \$59.00
- 4. Account No. 75603080-0 in the amount of \$51.68

Miss Cannon informed the Commissioners that no penalty on any of the above accounts have been waived in the last five (5) years. After discussion, the Commissioners authorized Miss Cannon to waive penalties on the accounts listed above and instructed her to send revised bills to the consumers.

Miss Cannon then informed the Commissioners that she received a request from a consumer (Account No. 75351170-0) for extended time to pay. Miss Cannon informed the Commissioners that the customer was already granted two three-month extensions without incurring penalty.
