Miss Cannon informed the Commissioners that she received the bid results from the Hicksville Water District's bid for the purchase of Sodium Chloride, "Solar Salt" that was received on Thursday December 4th, 2025. The bid was awarded to Morton Salt for the period of January 1, 2025 through December 31, 2025 at a cost of \$240.82/ton, with the option to extend for two (2) additional one (1) year periods at a cost of \$250.46/ton for 2027 and \$260.49/ton for 2028. The Jericho Water District will "piggyback" off the Hicksville Water District bid under the terms of the Long Island Water Conference Purchasing Cooperative (LIWCPC). After discussion, and upon motion duly made and seconded, it was

RESOLVED that the Commissioners authorized the purchase of Sodium Chloride, "Solar Salt" from Morton Salt based upon the Hicksville Water District's contract for these services.

Miss Cannon informed the Commissioners that she received the bid results from the Hicksville Water District's bid for the purchase of Peroxide that was received on Thursday December 4th, 2025. The bid was awarded to U.S. Peroxide LLC, dba USP Technologies for the period of January 1, 2025 through December 31, 2025 at a cost of \$3.71/gallon, with the option to extend for two (2) additional one (1) year periods (extension rate to be negotiated at the time of renewal). The Jericho Water District will "piggyback" off the Hicksville Water District bid under the terms

of the Long Island Water Conference Purchasing Cooperative (LIWCPC). After discussion, and upon motion duly made and seconded, it was

RESOLVED that the Commissioners authorized the purchase of Peroxide from U.S. Peroxide LLC, dba USP Technologies based upon the Hicksville Water District's contract for these services.



Miss Cannon informed the Commissioners that Eagle Control informed the District that they would not be able to extend Contract No. G1-24 CBS & PBS Tank Alarm Maintenance & Repair due industry wide price increases. Mr. Logan informed the Commissioners that he will be looking to rebid the contract in early 2026.

The following claims were then audited and approved for payment: General Fund #30041 to #30070 and Construction Fund #2858 to #2860.
